#### 10am to 12noon - CPD Workshop "Forest Value as an Alternative Fact"

#### Presenter: Bill Liley

Bill Liley is Managing Director of Indufor Asia Pacific, a NZIF Registered Member and long-standing member of the NZIF Valuation Working Party.

Bill's expertise includes the assessment of forest quantity and condition, and the projection of its wood supply capability and cash flows. These provide the primary elements of forest value estimation, which extends to include treatments of land cost, risk and cost of capital. He has undertaken projects in forest estate modelling and valuation in Oceania, Africa, South and Central America and China.

Bill wonders how we should consider valuation in the era of Donald Trump. If alternative facts are acceptable, can't the forest value be anything that you like? In addition, we expect Bill to look at the dynamic nature of valuations in which the ground continues to move beneath us. Battle lines continue to be drawn and redrawn on the tree crop/land interface and whether the analysis should include single or multiple rotations. A case for multiple discount rates for different parts of the business beckons. Box's aphorism that "All models are wrong, but some are useful" remains distinctly appropriate. When we think that we have secured a common if fragile understanding with the client, the auditors lurch in and set off another round of mayhem.

Bill will also provide an update on the current review of the NZIF Valuation Standard.

### 1pm to 3pm - CPD Workshop "The role of ethics for a forestry professional"

Presenter: Professor Tim Dare

Tim Dare is a Professor in Philosophy at The University of Auckland and a Barrister and Solicitor of the High Court of New Zealand. His research interests include applied and professional ethics, Legal ethics, Philosophy of Law, Medical ethics, Ethical Analysis of Predictive Risk Modelling. He has also had a number of non-research roles on clinical ethics committees and writes on issues he has encountered in those roles.

The importance of ethical standards amongst NZIF members has taken on added importance with the recent granting of an exemption under the Real Estate Agents Act to NZIF Registered Members. Professor Dare recently presented a series of workshops hosted by the Valuers Registration Board on the underlying ethical issues which have been prevalent in complaints to the Board over a number of years. Regular attendance at ethics modules is a mandatory requirement for registered valuers and Professor Dare will be able to draw parallels in the ethics expected of valuers and forestry professionals.

**Woods Contracting** - will showcase the latest in mechanised harvesting technology on the foothills around Nelson.

**Nelson Pine Industries** - the site visit will give a guided tour of the Laminated Veneer Lumber (LVL) production line.

Lunch – Alchemy Arts & Cafe

**XLAM** – will show what can be done when combining locally produced LVL with Douglas fir and Radiata pine solid timber to create Cross Laminated Timber (CLT).
