## Annual General Meeting.

The Secretary, in his Annual Report for the year ending 31st March, 1945, recorded the election of 5 new Associate Members and the advancement of one Associate Member to Member. Several other applications for membership had been received.

On the proposal of the President, Mr. H. R. Blandford, O.B.E., was asked to accept Honorary Membership of the Institute. Mr. Blandford has since accepted.

Some discussion took place on the qualifications required of non-graduate foresters seeking advancement to full membership. It was pointed out that there was a danger of over emphasising the importance of the thesis, article or report required and that the general experience and status of the applicant was of greater significance. It was agreed also that the thesis, article or report must be original, and not purely descriptive or routine work.

A lengthy debate took place on the question of qualifications of Student Members. Opinions were divided. Some members maintained that general acceptance of all reasonable applicants would be a material encouragement to potential foresters, and the Institute would benefit later in membership and interest, and would not be faced with the danger of the establishment of a rival body.

Others held that there was no particular advantage in the admittance of Student Members and there was a danger of a number joining who would be unsuccessful in the profession later but retain the right of membership till 28 years old, while others would not qualify for Associate Membership at that age and would have to resign until they were able to do so.

No finality was reached at the meeting.

## Wellington Section.

No meetings were held during the year, due to difficulty in getting members together.

# Rotorua Section.

The Section again had an active and highly successful year. At the Annual Meeting held on the 24th May, Mr. Owen Jones was elected Chairman and Mr. J. F. Lysaght was re-elected Secretary.
