ilco Products Ltd's spot cultivation system has been introduced to the South American forest industry. Lindsay Willis, managing director of the Rotorua forest equipment manufacturer, travelled to Chile, Argentina and Uruguay during June to view forest operations in the three countries. His visit was to oversee the installation of the first two units; one on trial in the Eighth Region of Chile with Forestal Mininco S.A. and the other sold to PROTISA in Corrientes, Argentina.

The Wilco Spot Cultivator is a patented tool designed to create and improve optimum planting sites for forestry and other trees at establishment. The unit is a one piece, excavator mounted, ground engaging tool comprised of two main components: a rake made from heavy duty fabricated steel and a cast ripper. There are no moving parts or hydraulic hoses. The unit is mounted in 5-10 minutes on any standard 20 tonne hydraulic exavator which is an increasingly easily available and versatile carrier.

The Wilco Spot Cultivator was developed over many years to cope with a wide variety of forest establishment problems that had previously presented difficulties and extra costs prior to, and after, planting.
